Minutes for Meeting January 24, 2023

The Mayor and Board of Aldermen of the Town of Alexandria met for the regular monthly meeting on January 24, 2023 at 7:00 P.M. The meeting was held in the conference room at the Alexandria Town Hall – DeKalb County, Tennessee.

The council members in attendance were: Lynne Dickerson, Curtis Rutter, and Justin Chapman. Quorum established. The meeting commenced with a moment of silence in honor of deceased Mayor Lloyd Dyer followed by the Pledge.

Mayor Russell Bradshaw requested that the minutes from the October 25, 2022 meeting be reviewed. Alderman Lynne Dickerson made a motion to accept the minutes for October 25, 2022 as presented. Motion seconded by Alderman Rutter. Motion passed unopposed.

Mayor Bradshaw opened the floor for citizen's comments.

Donny Bearden of 410 Locust St addressed the Board concerning speeding on Locust Street.

DEPARTMENT MONTHLY REPORTS

Senior Center Report was presented by Alderman Lynne Dickerson. Alderman Dickerson stated that they are waiting on an appointment of a new Director by the County Mayor. Former Director Sandy Brown added that there have been a few applicants and that the hiring decision has been pushed out several weeks.

Police Report presented by Police Chief Chris Russell; see attachment A.

Street Report; see attachment B. Workshop set for 6pm February 6, 2023.

Fire Report was presented by Fire Chief John Partridge. Chief Partridge completed several courtesy fire code inspections of businesses to help with those items that will be considered violations. Middle Tennessee Electric/Tennessee Valley Authority Grant paid for ten (10) new helmets. Fire Department has also received a State Fire Marshall Grant twenty-two thousand dollars (\$22,000) with zero match for turnout gear. There have been two new applicants to the Department. Steve Adams received a scholarship to go to Florida for a five day leadership academy. Joel Loudermilk is attending EMT school. Workshop set for 6pm February 6, 2023.

Water/Sewer Report; no one in attendance.

Financial Report was presented by Mrs. Tetlow, CMFO; see attachment C. Mrs. Tetlow went over the 2021-2022 Audit briefly stating that there was an increase in net position for all Funds. First budget workshop has been set for 6pm February 21, 2023.

Engineer Report was presented by Mr. Jerry Warren. ARPA projects have been submitted to TDEC for the Meter project, Sewer Lift station, and Sykes Pump Station. We continue to work with TDEC to revise the applications. State Revolving grants and loans are being sought. Sewer replacement for the TDOT project has been delayed but should begin within the next few weeks. TDOT Bridge inspection has been received for the Edgewood Bridge over Hickman Creek. Mr. Warren is working on 80/20 rehab funding to help with the repairs.

Attorney Report was presented by Vester Parsley. Meeting with David Lawrence about the easement tomorrow for the master meter.

Mayor Report was presented by Mayor Bradshaw. He is appointing Alderman Curtis Rutter to the Zoning Board as the second Board of Alderman representation.

NEW BUSINESS

Mayor Bradshaw requested that the check signers be updated to remove Lloyd Dyer and add Russell Bradshaw to all financial accounts. Alderman Dickerson made a motion to approve adding

Mayor Russell Bradshaw and removing Lloyd Dyer as check signer for all accounts. Alderman Rutter seconded the motion. Motion passed unopposed.

Drug Fund account requires multiple signers. Mrs. Tetlow stated that the Police and Drug Equipment Fund account needs to remove Lloyd Dyer as a signer and add Mayor Russell Bradshaw and Elizabeth Tetlow along with current signer Chief Christopher Russell. Alderman Rutter made a motion to approve Mayor Russell Bradshaw, Elizabeth Tetlow, and Chief Christopher Russell as signers on the Police and Drug Equipment Fund. Alderman Dickerson seconded the motion. Motion passed unopposed.

Mrs. Tetlow noted that the Wilson Bank and Trust accounts need an additional signer. Mayor Bradshaw requested that Alderman Justin Chapman be listed as a signer on the accounts at Wilson Bank and Trust. Alderman Rutter made a motion to add Justin Chapman as a signer to the accounts at Wilson Bank and Trust. Alderman Dickerson seconded the motion. Motion passed unopposed.

Discussion was held concerning the date and planning of Old Timers Day. Mrs. Sandy Brown is requesting that we partner with the Alexandria Fire Department Association Motorcycle Rally on August 26, 2023.
