Minutes for Meeting February 23, 2021

The Mayor and Board of Aldermen of the Town of Alexandria met for the regular monthly meeting on January 26, 2021 at 7:00 P.M. The meeting was held via online platform and in person in the conference room at the Alexandria Town Hall – DeKalb County, Tennessee.

The council members in attendance in person were: Lloyd Dyer, Lynne Dickerson, and Rusty Bradshaw. Attendance online were; Charlie Fraser Quorum established.

Attorney Vester Parsley was also present. The meeting commenced with a statement from Vice Mayor Lloyd Dyer, "On March 20, 2020, Governor Bill Lee signed Executive Order No. 16 ("the Order") extended by Order Nos. 34, 51, 60, 65, and 71, which suspends the requirements of the Tennessee Open Meetings Act ("TOMA") to the extent necessary to allow any governing body subject to the requirements of TOMA to meet and conduct essential business by electronic means if the body determines meeting electronically is necessary to protect the health, safety, and welfare of Tennesseans in light of the COVID-19 pandemic. Based on the above orders the Mayor and Board of Aldermen have determined that holding this meeting electronically is necessary to protect public health, safety, and welfare in light of the coronavirus."

Vice Mayor Lloyd Dyer requested that the minutes from the January 26, 2021 meeting be reviewed. Alderman Charlie Fraser made a motion to accept the minutes for January 26, 2021 as presented. Motion seconded by Alderman Lynne Dickerson. Motion passed unopposed.

Vice Mayor Dyer opened the floor for citizen's comments.

Jimmy Hunt 117 High Street addressed the Board concerning installing an additional light pole outside his property. Discussion tabled for additional information.

DEPARTMENT MONTHLY REPORTS

Water/Sewer Report was presented by Mr. Jerry Warren, Engineer. There was an EPA video conference on February 19, 2021 concerning the site inspection. As a result of the EPA meeting, Jerry Warren contacted TDEC to confirm the necessary changes. The end result will lower the reporting numbers and effect the DMR reporting in a positive manner. Mrs. Elizabeth Tetlow reported on water as there was an increase in water purchased versus water sold and leak detection.

Engineering Report was presented by Jerry Warren. Edgewood Box Culvert came in under budget. Industrial Road ponding at Edgewood was discussed. Hwy 70 expansion was discussed. There are only two (2) easements still needed at this time. SRF has sent the Town a letter of financial sufficiency.

Alderman Dickerson made a motion for Warren and Associated to get estimates on repairing the asphalt at the corner of Industrial and Edgewood due to ponding water. Motion seconded by Alderman Fraser. Roll Call vote.
