Financial Report was presented by Mrs. Tetlow, CMFO; discussion was held concerning the budget and budget amendments.

Engineer Report was presented by Mr. Jerry Warren. TDOT project lacks one (1) service connection to be completed on the sewer portion of the project. ARPA Reimbursement Grant of six hundred seventy four thousand nine hundred and thirty-one dollars and seventy six cents (\$674931.76) has been awarded and we are awaiting the finalized contract to begin the Meter project, Sewer Lift station, and Sykes Pump Station updates. Wilson County waterline sale is progressing, master meter is ready to install. This will be the last part to completing the sale. Mr. Warren addressed the Board concerning the funds needed to work on the Wastewater Plant. He believes that this project might be eligible for the TDEC ARPA Competitive Grant.

Attorney Report was presented by Attorney Vester Parsley. Attorney Parsley discussed delinquent taxes and the tax sale that will be held within the next few months. Opioid Settlement package was discussed. Attorney Parsley advised that the money is restricted and should be put into the Drug Fund and used to address opioid abuse.
