The Mayor and Board of Aldermen of the Town of Alexandria met for the regular monthly meeting on October 25, 2022 at 7:00 P.M. The meeting was held in the conference room at the Alexandria Town Hall – DeKalb County, Tennessee.

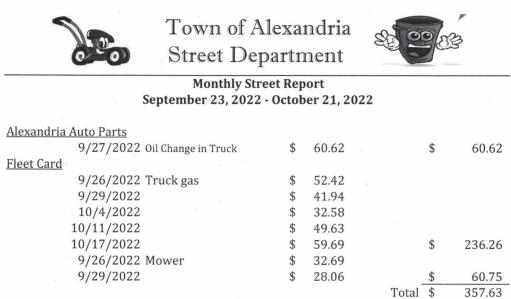
