# Minutes for Meeting October 26, 2021

The Mayor and Board of Aldermen of the Town of Alexandria met for the regular monthly meeting on October 26, 2021 at 7:00 P.M. The meeting was held in the conference room at the Alexandria Town Hall – DeKalb County, Tennessee.

The council members in attendance were: Lloyd Dyer, Charlie Fraser, Rusty Bradshaw, and Beth Tripp. Alderman Lynne Dickerson arrived at 7:06pm. Quorum established. Mayor Bennett Armstrong and Attorney Vester Parsley were also present. The meeting commenced with the Pledge and a prayer led by Attorney Parsley.

Mayor Bennett Armstrong requested that the minutes from the September 28, 2021 meeting be reviewed. Alderman Lloyd Dyer made a motion to accept the minutes for September 28, 2021 as presented. Motion seconded by Alderman Beth Tripp. Motion passed unopposed.

Public Hearing – Zoning Variances

Alexandria Planning and Zoning Committee met on October 7, 2021 and recommended the following zoning variances. Article VI Section 1.4 (4) Lot Area, Lot Width, Rear and Side Yards regarding Minimum rear yard (30ft) as well as Section 1.4 (2.1) Setbacks regarding Minor Streets (30ft) for residential use of any property zoned R-1, located at 113 Maple St. Property is referenced as DeKalb County Map 22G Grp B Parcel 25.02, containing approx. 0.18 acres.

Article VI Section 1.4 (4) Lot Area, Lot Width, Rear and Side Yards regarding Minimum rear yard (30ft) for residential use of any property zoned R-1, located at 125 Maple St. Property is referenced as DeKalb County Map 22G Grp B Parcel 25.01, containing approx. 0.2 acres

Mayor Armstrong opened the floor to comments. No comments were made. Mayor Armstrong closed the floor. Alderman Charlie Fraser made a motion to grant the variances as recommended by the Planning and Zoning board for 113 Maple Street and 125 Maple Street. Motion seconded by Alderman Rusty Bradshaw. Roll Call vote.

Mayor Armstrong opened the floor for citizen's comments. There were none.

#### DEPARTMENT MONTHLY REPORTS

Water/Sewer Report was presented by Mr. Rich Potter. Mr. Potter is expecting the land application permit to be approved over the next few weeks. Pump as Sykes is running on one pump. The lift station is still on the list for being pumped and rodded. Basin A is still in need of pumping so repairs can be made to the diffusers.

Fire report; see attachment B. In addition, there is a new program where volunteer department members can get six hundred dollars (\$600) stipend from the state for completion of thirty (30) hours of training.

Engineering Report was presented by Mr. Jerry Warren. Paving contractor is in the process of working the Industrial/Edgewood project into their schedule. Mr. Warren has received an expanded access document from EPA. Wilson Water Authority tabled the contract until their January meeting. TDOT Route 70 expansion is continuing. Mr. Warren has a contractor who will be looking at the influent meter at the Sewer Plant. Mr. Warren is currently working on a TEMA application for a twelve and a half percent (12.5%) grant match on a water project. Alderman Dyer made a motion to pursue the TEMA Grant to assist in funding the Sewer project to move the collection system out of Hickman Creek. Alderman Fraser seconded the motion. Roll Call vote.

Mayor report was presented by Mayor Armstrong. Town is taking over the Volunteer Park account that was previously held privately.

ARPA Premium Pay was discussed. Alderman Fraser made a motion to pay employees still employed with the Town who were employed from March 2020 through March 2021 premium pay in the amount of two thousand dollars (\$2000.00) full-time, part time five hundred (\$500.00) and two hundred and fifty dollars (\$250.00) based on working hours.

Resolution 20211026 accepting the DeKalb County Hazard Mitigation Plan for the Town of Alexandria. A motion was made by Alderman Dyer to accept the DeKalb County Hazard Mitigation Plan. Motion seconded by Alderman Fraser. Roll Call vote.
