Minutes for Meeting November 28, 2023

The Mayor and Board of Aldermen of the Town of Alexandria met for the regular monthly meeting on November 28, 2023 at 7:00 P.M. The meeting was held in the conference room at the Alexandria Town Hall – DeKalb County, Tennessee.

The council members in attendance were: Lynne Dickerson, Curtis Rutter, and Donnie Bearden Quorum established. Mayor Russell Bradshaw was also present. The meeting commenced with a prayer led by Attorney Vester Parsley and the Pledge of Allegiance.

Water/Sewer Report was presented by Mr. Rich Potter. Mr. Potter stated that one of the drives in the Sykes pumping station is not working properly. He is in the process of ordering a new one. Sewer Plant currently has no issues and is testing within limits. The manhole repair on Industrial Drive is almost complete.

Financial Report was presented by Mrs. Elizabeth Tetlow, CMFO; see attachment D.

Engineer Report was presented by Mr. Jerry Warren, Engineer. TDEC ARP funding is progressing through the procurement process. Water & Wastewater Authority of Wilson County water line sale is close to being finalized, awaiting TDEC approval on new pumps. Marq Labs has requested water availability for the fire lines. Mr. Warren presented an estimate for the concrete ramp at the Senior Citizen Center. Discussion was held, and tabled.

Attorney Report was presented by Attorney Vester Parsley. Attorney Parsley talked with an attorney concerning Marq Labs. Attorney Parsley recommended a survey and appraisal to go forward with the variance.

Mayor report was presented by Mayor Bradshaw. Mayor Bradshaw introduced the new Water Clerk and Town Recorder. He requested the Aldermen's help with the Christmas Parade on Sunday, December 3, 2023 at 5:00 pm.
