Minutes for Meeting November 30, 2020

The Mayor and Board of Aldermen of the Town of Alexandria met for the regular monthly meeting on November 30, 2020 at 7:00 P.M. The meeting was held via online platform.

The council members in attendance were: Lynne Dickerson, Charlie Fraser and Rusty Bradshaw. Quorum established.

Mayor Bennett Armstrong and Attorney Vester Parsley were also present. The meeting commenced with a statement from Mayor Bennett Armstrong, "On March 20, 2020, Governor Bill Lee signed Executive Order No. 16 ("the Order") extended by Order Nos. 34, 51, 60, and 65, which suspends the requirements of the Tennessee Open Meetings Act ("TOMA") to the extent necessary to allow any governing body subject to the requirements of TOMA to meet and conduct essential business by electronic means if the body determines meeting electronically is necessary to protect the health, safety, and welfare of Tennesseans in light of the COVID-19 pandemic. Based on the above orders the Mayor and Board of Aldermen have determined that holding this special meeting electronically is necessary to protect public health, safety, and welfare in light of the coronavirus."

Mayor Armstrong opened the floor for citizen's comments. None in attendance.

Mayor Armstrong requested that the minutes from the September 22 and November 10, 2020 meetings be reviewed. Alderman Lynn Dickerson made a motion to accept the minutes for September 22 and November 10, 2020 as presented. Motion seconded by Alderman Charlie Fraser. Roll Call vote.

DEPARTMENT MONTHLY REPORTS

Sewer/Water Report no one in attendance.

Police report was presented; see attachment A.

Fire report was presented by Assistant Chief John Partridge. Call volume is back to normal, COVID screening is still in place. Fire Department received a thousand dollar (\$1000.00) grant from Walmart for radios.

Streets report was presented by Mayor Armstrong; Streets Department spent one hundred sixtynine dollars and eighty cents (\$169.80).

Financial Report was presented by Mrs. Elizabeth Tetlow, CMFO; see attachment B.

Engineering Report was presented by Jerry Warren. He is currently working on the TDOT HWY 70 Project. Currently lacking six or seven (6 or 7) easements for the project. Edgewood Box Culvert contract sets have been sent to Concrete Structures for their signatures scheduling discussions will happen after the first week of December. SRF is waiting on the finalized Audit to review funding.

Attorney report was presented by Attorney Vester Parsley. Attorney Parsley reported on the TDEC meeting concerning the Sewer Permit fine. The fine will be paid out at one hundred and seventy–seven dollars (\$177.00) monthly for two (2) years.

NEW BUSINESS

Jerry Warren presented information to be presented at the Community Development Block Grant (CDBG) Public Meeting on Thursday December 6th, 2020 at 6:00pm. This grant will used for work on the six thousand (6000) feet of sewer line in the creek bed. The grant can be up to six hundred thousand dollars (\$600,000.00) with a match of twelve and a half percent (12.5%). Application is due in February. Looking at a FEMA Grant to assist in the repairs that are needed.

Christmas Parade – we are getting calls for registrations and donations are beginning to come in.

Alderman Fraser made a motion to adjourn. Alderman Dickerson seconded the motion. Motion passed.
