Minutes for Meeting August 25, 2020

The Mayor and Board of Aldermen of the Town of Alexandria met for the regular monthly meeting on August 25, 2020 at 7:00 P.M. The meeting was held in the conference room of Alexandria City Hall – DeKalb County, Tennessee.

The council members in attendance were: Lloyd Dyer, Lynne Dickerson, Charlie Fraser and Rusty Bradshaw. Quorum established.

Mayor Bennett Armstrong and Attorney Vester Parsley were also present. The meeting commenced with a prayer from Attorney Vester Parsley and the pledge of allegiance.

The meeting began with Mayor Armstrong requesting that the TUA Water and Sewer Rate Study Report be presented to the Board of Aldermen. Mrs. Elizabeth Tetlow, CMFO presented the report to the Board. The report and adherence to the findings of the report were mandated under Court Order of the Water and Wastewater Finance Board.

Vice Mayor Lloyd Dyer opened the floor for citizen's comments. Tara Gregory, 201 Curtis Avenue addressed the Board concerning water rates and billing processes. Lauren Hall, 103 Poplar addressed the Board concerning her individual water usage. Julie Nugent, 307 W Main Street asked the Board if there were any grants that would help with the water cost for the consumers. Arbutis Dotsun-Morrison, 101 Popular Street addressed the Board concerning zero use billing and location of meters. Vice Mayor Dyer turned the meeting back over to the Mayor.

Mayor Armstrong requested that the minutes from the July 28, 2020 meeting be reviewed. Alderman Lloyd Dyer made a motion to accept the minutes for July 28, 2020 as presented. Motion seconded by Alderman Charlie Fraser. Motion passed unopposed.

DEPARTMENT MONTHLY REPORTS

Sewer Report was presented by Mr. Rich Potter. They replaced the electrical board on the lift station and inspected the manhole covers in Hickman Creek. During inspection they noted repairs that are needed and took pictures of the manhole covers..

Water Report was presented by Mr. Brian Grisham. There were 2 service line leaks that were fixed this month. One was a rock that had rubbed a copper service line the other was a fitting that broke apart. Discussion was had concerning a pump station needed on Goose Creek.

Engineering Report was presented by Jerry Warren, Engineer. State Revolving Fund sent a letter requesting additional financial requirements for funding. TUA report will assist in the response. Box Culvert is out to bid. Bid opening is September 10th at 2pm

Mayor's report was presented by Mayor Armstrong. He will be focusing on the Cemetery and how other municipalities run those as a fund.

Attorney report was presented by Attorney Vester Parsley. Attorney Parsley did not have anything to report.

OLD BUSINESS

Community Park – The park committee is applying for the BlueCross BlueShield Healthy Places Grant. BCBS in celebration of their 75th anniversary is giving the grant requesters a choice of

six (6) different plans. Applications are due on August 31st. The Board recommended the Community Hub to the committee. The bid process has started for the forty thousand dollar (\$40,000.00) Three Star Grant. This grant will be used for a play area in the upper portion of the Community Park in the BCBS colors.

NEW BUSINESS

TDEC Letter – A letter was received on August 25, 2020 concerning the effluent from the DMR's as exceeding Permit levels. The letter was reviewed to determine what information will be needed to address the letter and the Permit numbers. Mr. Potter and Mr. Warren will review numbers to see where we are trending and what still needs to be addressed at the sewer plant to achieve the required permit numbers.

Alderman Lynne Dickerson won the election for Alderman and was sworn in.
